

Pursuant to Article 4.2 and 4.7 of the Law on Transmission of Electric Power, Regulator and System Operator of Bosnia and Herzegovina (Official Gazette of BIH, 7/02, 13/03, 76/09 and 1/11), Article 33 of the Rule of Practice and Procedure of the State Electricity Regulatory Commission (Official Gazette of BIH, 2/05) and Article 49, paragraph (7) of the Licensing Rule – Consolidated Version (Official Gazette of BIH, 63/16), at the session held on 17 July 2024, the State Electricity Regulatory Commission passed a

DECISION ON AN EXTENSION OF USE OF THE LICENSE

1. The Company “Energy Financing Team” d.o.o., Bileća, the holder of the international electricity trading license, registration number 05-28-12-88-18/23 of 20 April 2023, continues using the previously granted license under at the new address - Skrobotno 4, Bileća, with the license conditions remaining unchanged.
2. This Decision shall come into force on the day of the adoption and the operative part of the Decision shall be published in the “Official Gazette of BIH” and the official gazettes of the Entities.

Statement of Rationale

The Company “Energy Financing Team” d.o.o., seated in Bileća, is the holder of the international electricity trading license, which was issued in accordance with the Decision of the State Electricity Regulatory Commission (hereinafter: SERC) number 05-28-12-88-17/23 of 20 April 2023 for the period from 1 July 2023 to 30 June 2028.

The licensee notified SERC of the change of the Company’s address by its act of 19 June 2024, which was received on 27 June 2024 and registered under number 05-28-13-257-1/24, with the aim of having these data changed in the SERC official records accordingly.

Notification of the change of data was also supported by the relevant documentation, and through an insight into the Decision on registration of Regional Commercial Court in Trebinje number 062-0-Reg-24-000161 of 17 June 2024, it was established that the change of the company’s address of the subject of registration “Energy Financing Team” d.o.o., Bileća, had been entered into the court register, with the new address of the seat of the aforementioned legal person being Skrobotno 4, Bileća.

Taking into account that a change of name, seat or address of a licensee is not considered a change of the license pursuant to the Licensing Rule – Consolidated Version, and taking into consideration the fact the data changed have no effect on the licensee’s legal status and continuous unhindered use of the license by the same legal person, pursuant to Article 49 paragraph (7) of the Licensing Rule – Consolidated Version it was decided as stated in the operative part of the Decision.

Pursuant to Article 9.2. of the Law on Transmission of Electric Power, Regulator and System Operator of Bosnia and Herzegovina, proceedings may be initiated before the Court of Bosnia and Herzegovina against this Decision by filing a lawsuit within sixty (60) days of receipt thereof.
