Pursuant to Article 4.2. and 4.7. of the Law on Transmission of Electric Power, Regulator and System Operator of Bosnia and Herzegovina (Official Gazette of BIH, 7/02, 13/03, 76/09 and 1/11), Article 33 of the Rule of Practice and Procedure of the State Electricity Regulatory Commission (Official Gazette of BIH, 2/05) and Article 49, paragraph (7) of the Licensing Rule – Consolidated Version (Official Gazette of BIH, 63/16), at the session held on 15 January 2025, the State Electricity Regulatory Commission passed a

DECISION

ON THE CONTINUED USE OF THE LICENCE

- 1. Legal person "Global Ispat koksna industrija" d.o.o., Lukavac, the holder of the temporary licence for performance of the international electricity trading activity, registration number 05-28-12-302-20/24 of 6 November 2024, continues to use the previously granted licence under the name "Koksara" d.o.o., Lukavac for the production of coke, chemical products and energy, with the licence conditions remaining unchanged.
- 2. This decision shall come into force on the day of the adoption while the operative part of the Decision shall be published in the "Official Gazette of BIH" and the official gazettes of the Entities.

Statement of Rationale

Legal person "Global Ispat koksna industrija" d.o.o., Lukavac, seated in Lukavac, Željeznička 1, is a holder of the temporary licence for the international electricity trading activity granted by the Decision of the State Electricity Regulatory Commission (hereinafter: SERC), number 05-28-12-302-19/24 of 6 November 2024, for the period from 24 November 2024 to 23 November 2026.

The licensee notified SERC of the change of the Company's name by a communication of 26 November 2024, which was received on 31 December 2024 and registered under number 05-28-13-405-1/24, for the purpose of changing these data in the SERC's official records accordingly.

Notification of the change of data was also supported by the relevant documentation, and through an insight into the Decision on the change of data of the Municipal Court in Tuzla number 032-0-Reg-21-001408 of 6 November 2024, it was established that the change of the company's name was entered into the court register. Instead of the previous name "Global Ispat koksna industrija" d.o.o., Lukavac, the name "Koksara" d.o.o., Lukavac for the production of coke, chemical products and energy was entered accordingly.

Taking into account that a change of name, seat or address of a licensee is not considered a change of the licence pursuant to the Licensing Rule – Consolidated Version, and taking into consideration the fact the data changed have no effect on the licensee's legal status and continuous unhindered use of the licence by the same legal person, pursuant to Article 49, paragraph (7) of the Licensing Rule – Consolidated Version, it was decided as provided in the operative part of the Decision.

Pursuant to Article 9.2. of the Law on Transmission of Electric Power, Regulator and System Operator of Bosnia and Herzegovina, proceedings may be initiated before the Court of Bosnia and Herzegovina against this decision by filing a lawsuit within 60 days of receipt thereof.
